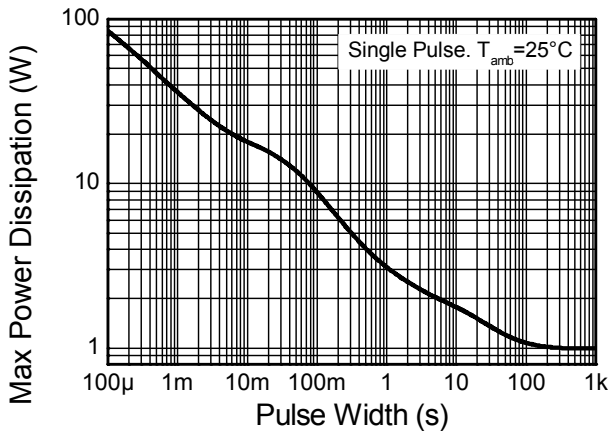

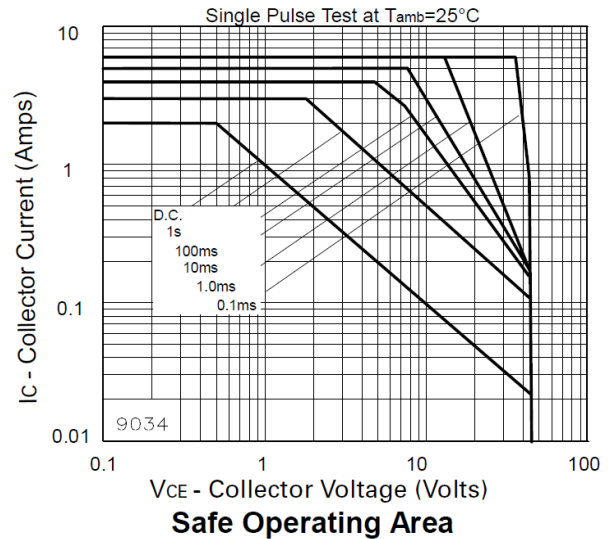
**Derating Curve**

**Pulse Power Dissipation**



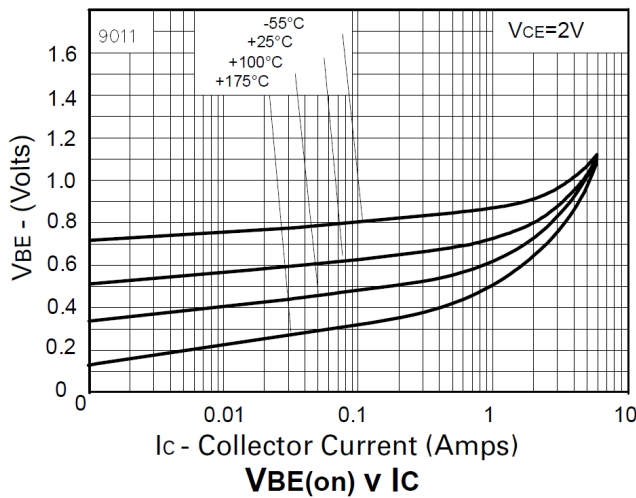
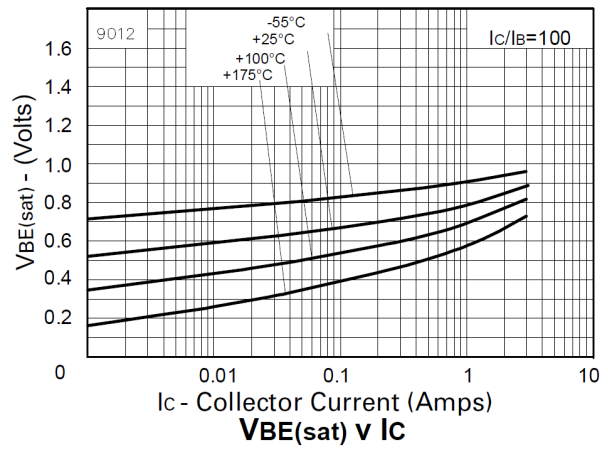
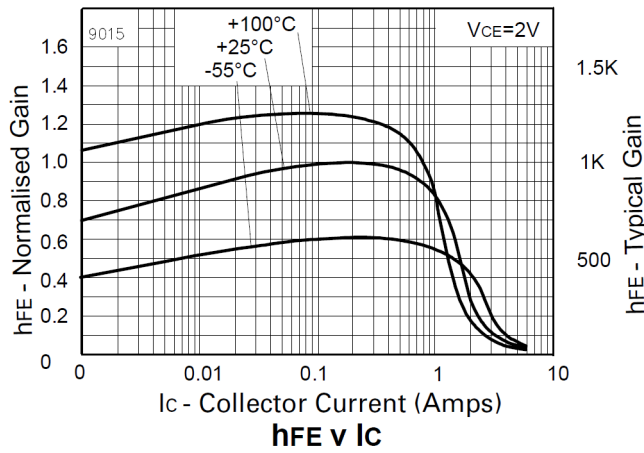
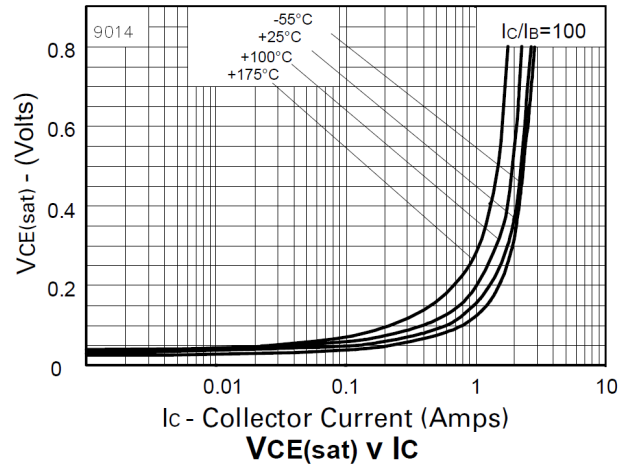
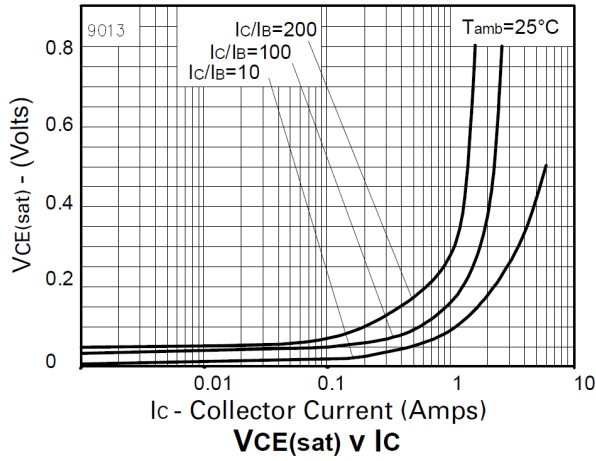
