




**Safe Operating Area**










**Typical Transfer Characteristics** 



**Normalised Curves v Temperature** 




**On-Resistance v Drain Current** 




Source-Drain Diode Forward Voltage




Capacitance v Drain-Source Voltage




Gate-Source Voltage v Gate Charge




Basic Gate Charge Waveform

Switching Time Waveforms




Switching Time Test Circuit




