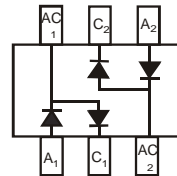

Top View



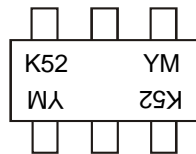
Top View

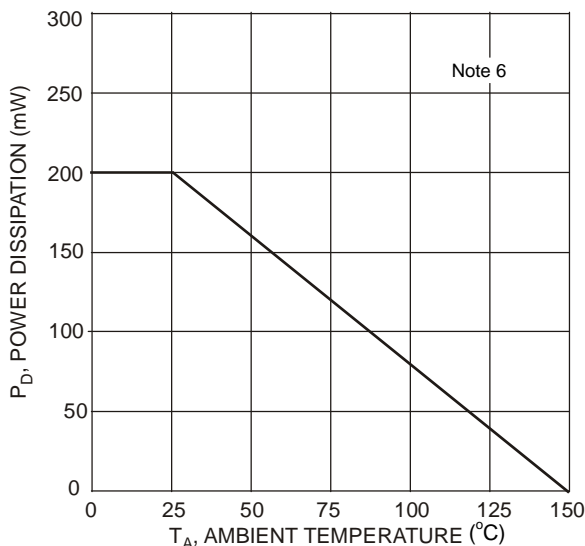


Fig. 1 Power Derating Curve, Total Package

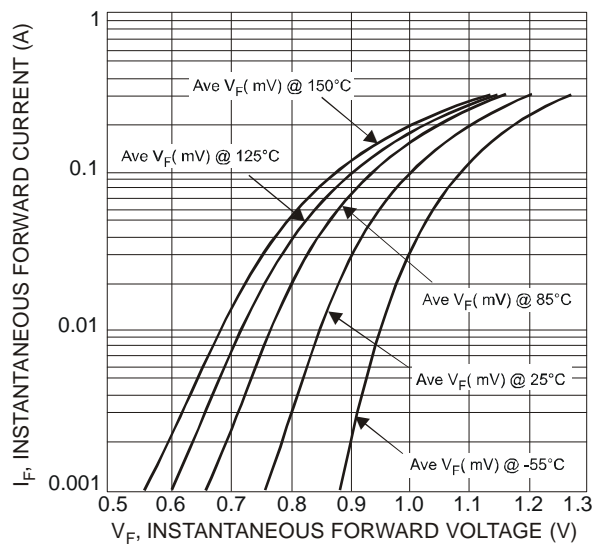


Fig. 2 Typical Forward Characteristics, Per Element

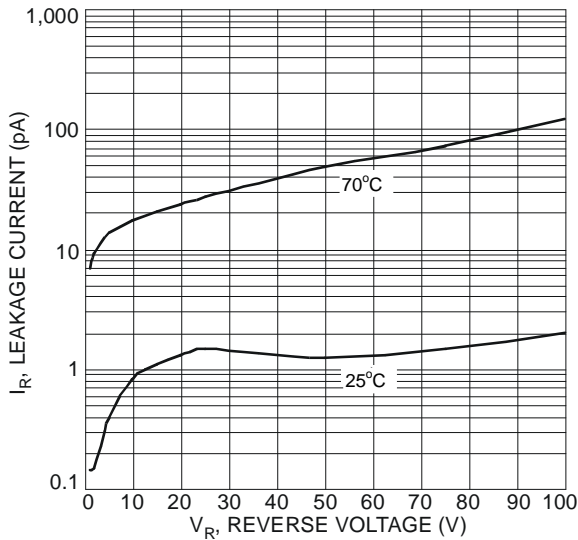


Fig. 3 Typical Reverse Characteristics, Per Element

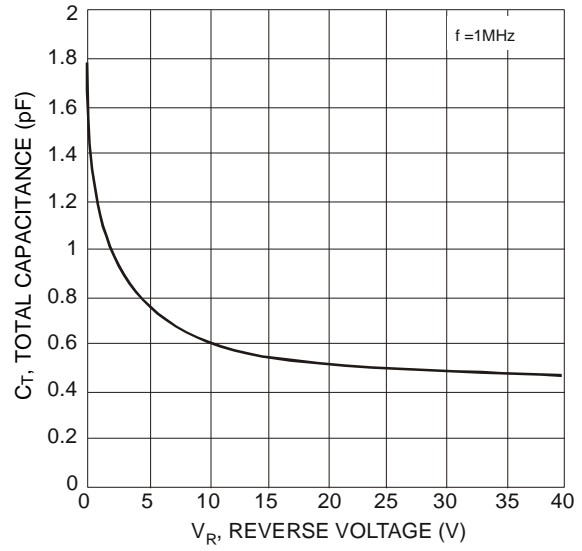


Fig. 4 Typical Total Capacitance

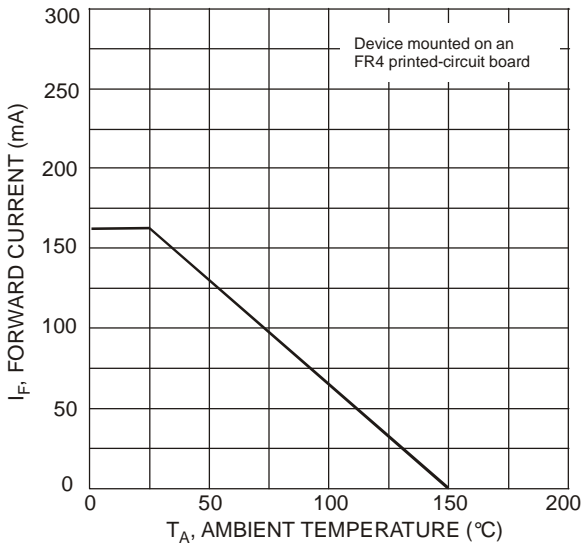
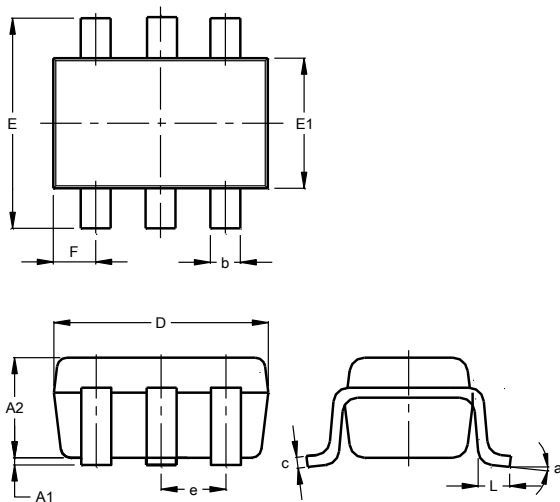


Fig. 5 Current Derating Curve, Per Element

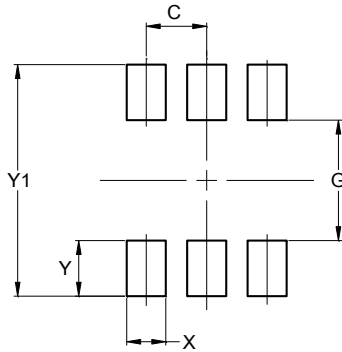
