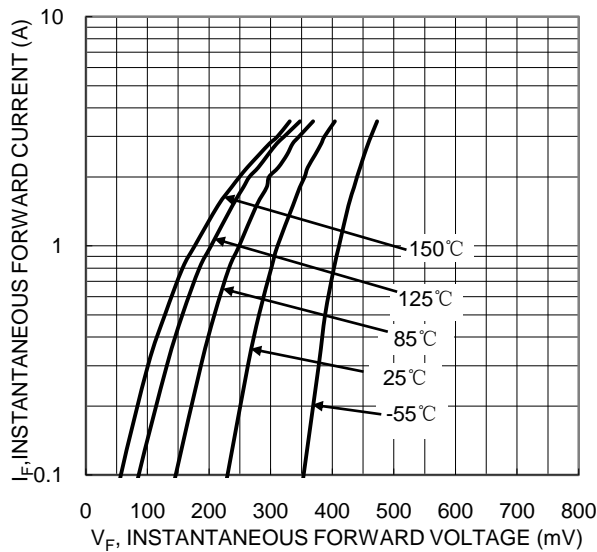


Figure 1. Typical Forward Characteristics

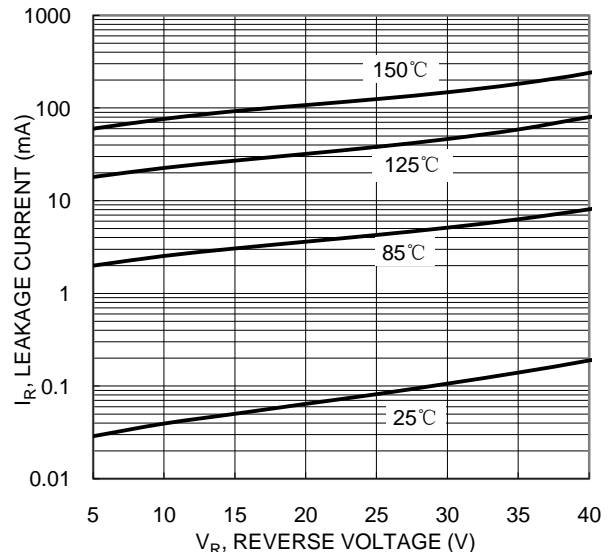


Fig.2 Typical Reverse Characteristics

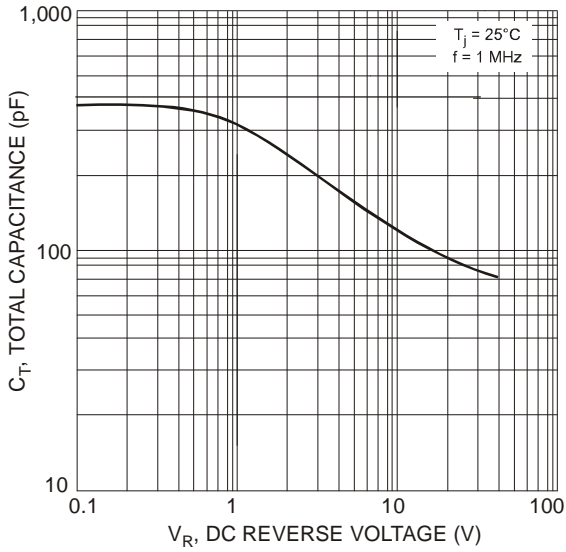


Fig. 3 Total Capacitance vs. Reverse Voltage

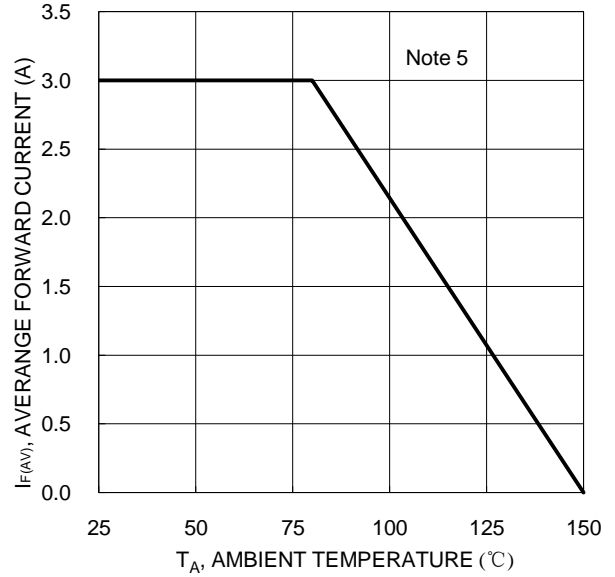


Figure 4. DC Forward Current Derating

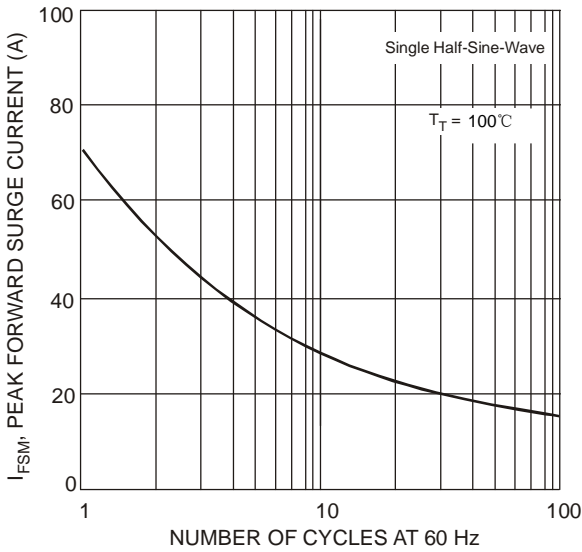
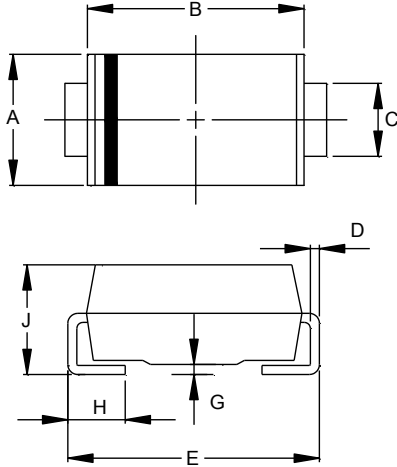


Fig. 5 Max Non-Repetitive Peak Forward Surge Current

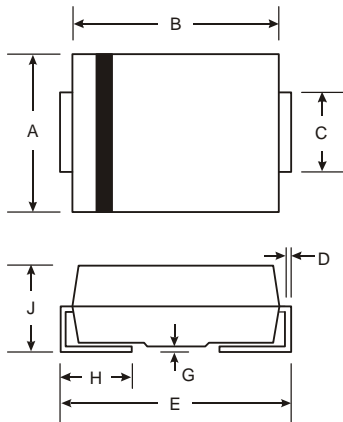

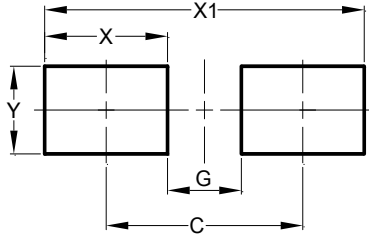

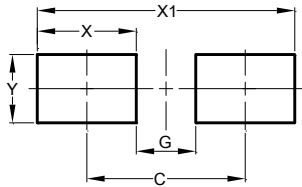
