 V_{DS} , DRAIN-SOURCE VOLTAGE (V) Figure 1. Typical Output Characteristic




Figure 3. Typical On-Resistance vs. Drain Current and Gate Voltage




Figure 5. Typical On-Resistance vs. Drain Current and Temperature




Figure 2. Typical Transfer Characteristic




Figure 4. Typical Transfer Characteristic




Figure 6. On-Resistance Variation with Temperature









Figure 7. On-Resistance Variation with Temperature



V_{SD}, SOURCE-DRAIN VOLTAGE (V) Figure 9. Diode Forward Voltage vs. Current




Figure 11. Gate Charge





Figure 8. Gate Theshold Variation vs. Junction Temperature



V_{DS}, DRAIN-SOURCE VOLTAGE (V) Figure 10. Typical Junction Capacitance




Figure 12. SOA, Safe Operation Area







Figure 13. Transient Thermal Resistance
