

RATING AND CHARACTERISTIC CURVES FB5150D





FIG.3 TYPICAL FORWARD CHARACTERISTICS



INSTANTANEOUS FORWARD VOLTAGE, (V)






FIG.4 TYPICAL JUNCTION CAPACITANCE






