




Figure 1. DC Current Gain




Figure 3. Turn-On Time




Figure 5. Safe Operating Area




Figure 2. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage




Figure 4. Turn-Off Time




Figure 6. Power Derating




Figure 7. 3-LEAD, TO-252, JEDEC TO-252 VAR. AB, SURFACE MOUNT (DPAK) (ACTIVE)
