










TO-226AE Package Dimensions




Sketch B (Top View)

Component lateral movement

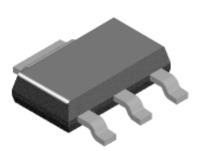





