## 3.3 V Hex inverter

### 1. General description

The 74LVT04 is a hex inverter. This device is fully specified for partial power down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.

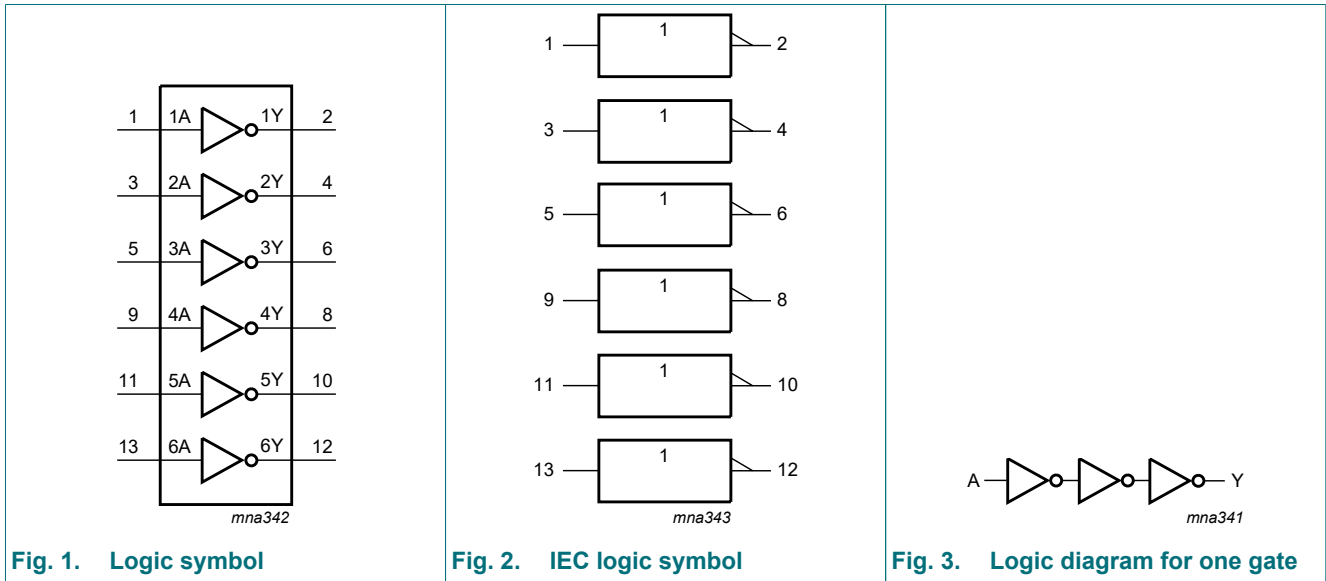

  - JESD8C (2.7 V to 3.6 V)
- ESD protection:
  - HBM JESD22-A114E exceeds 2000 V
  - MM JESD22-A115-A exceeds 200 V
- Specified from -40 °C to +85 °C

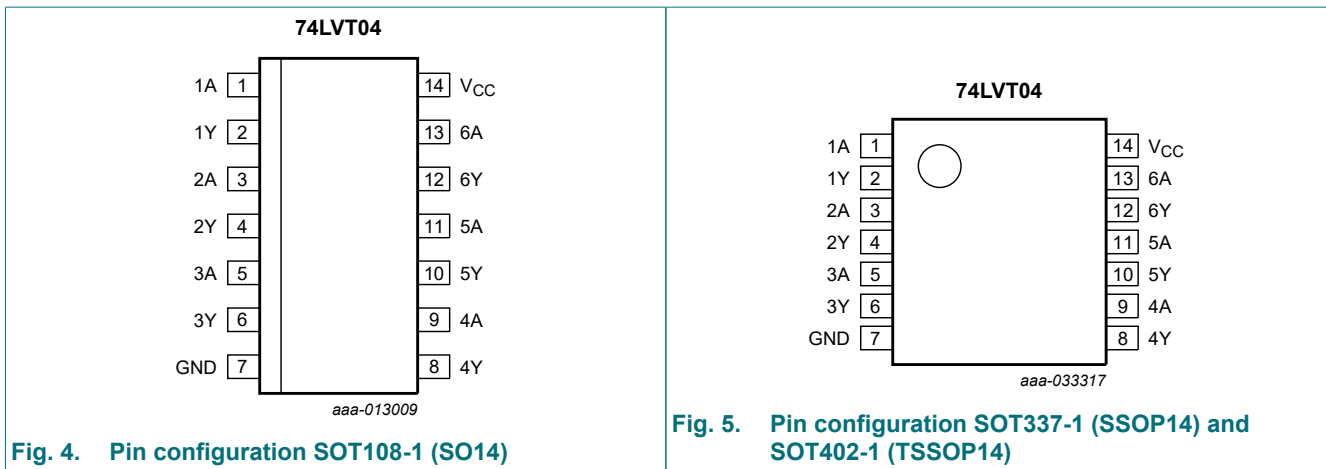

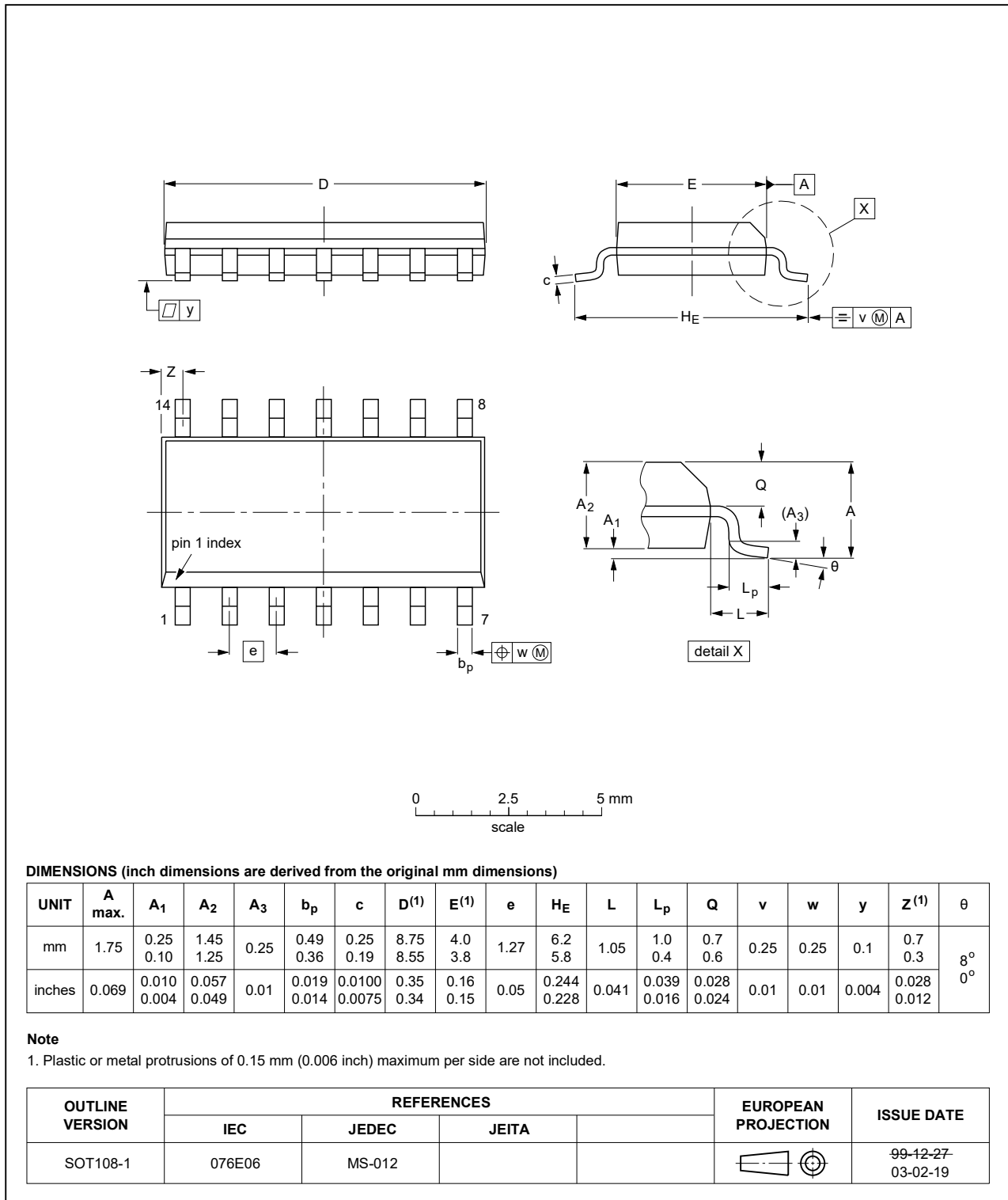


Fig. 8. Package outline SOT108-1 (SO14)

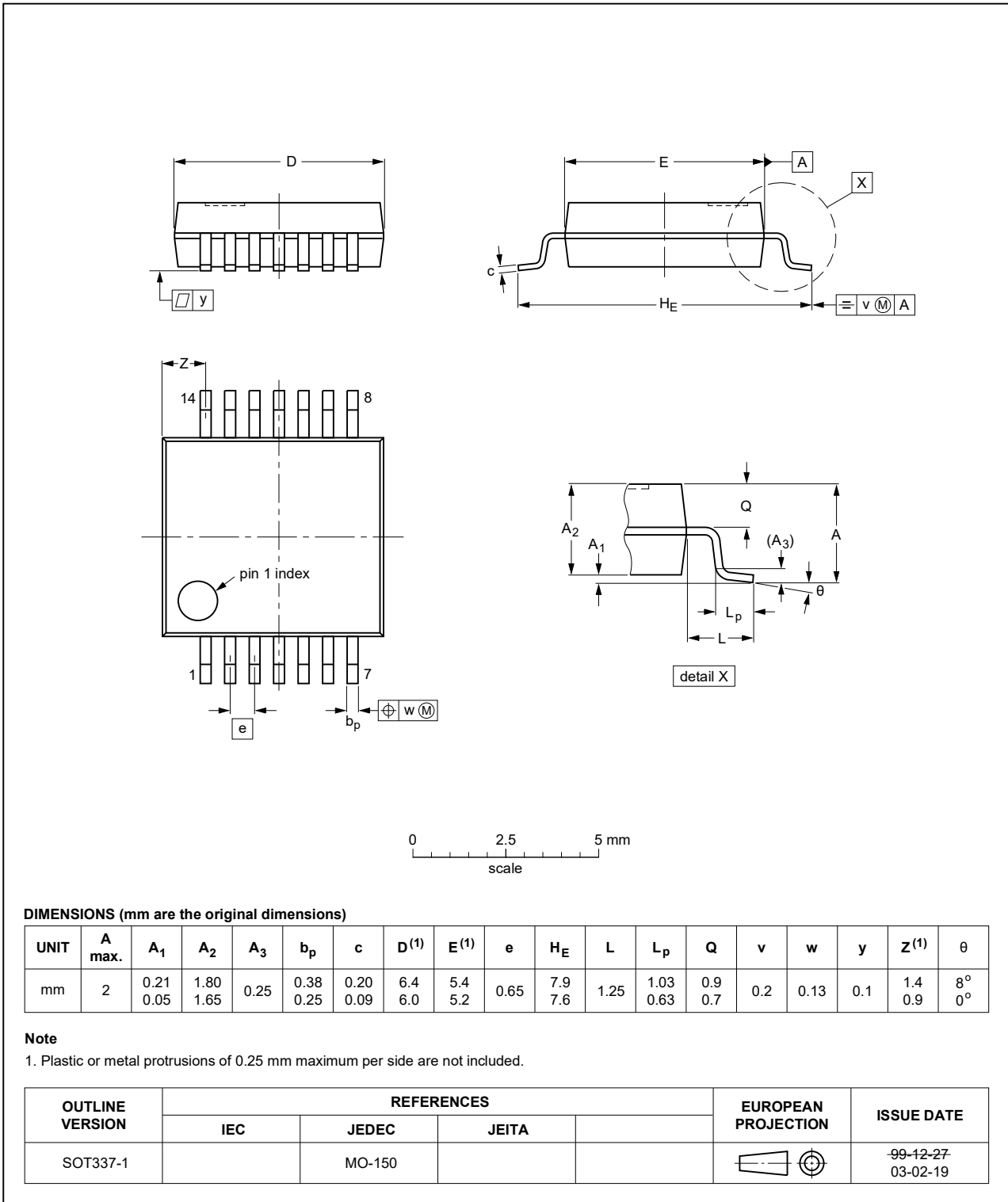


Fig. 9. Package outline SOT337-1 (SSOP14)

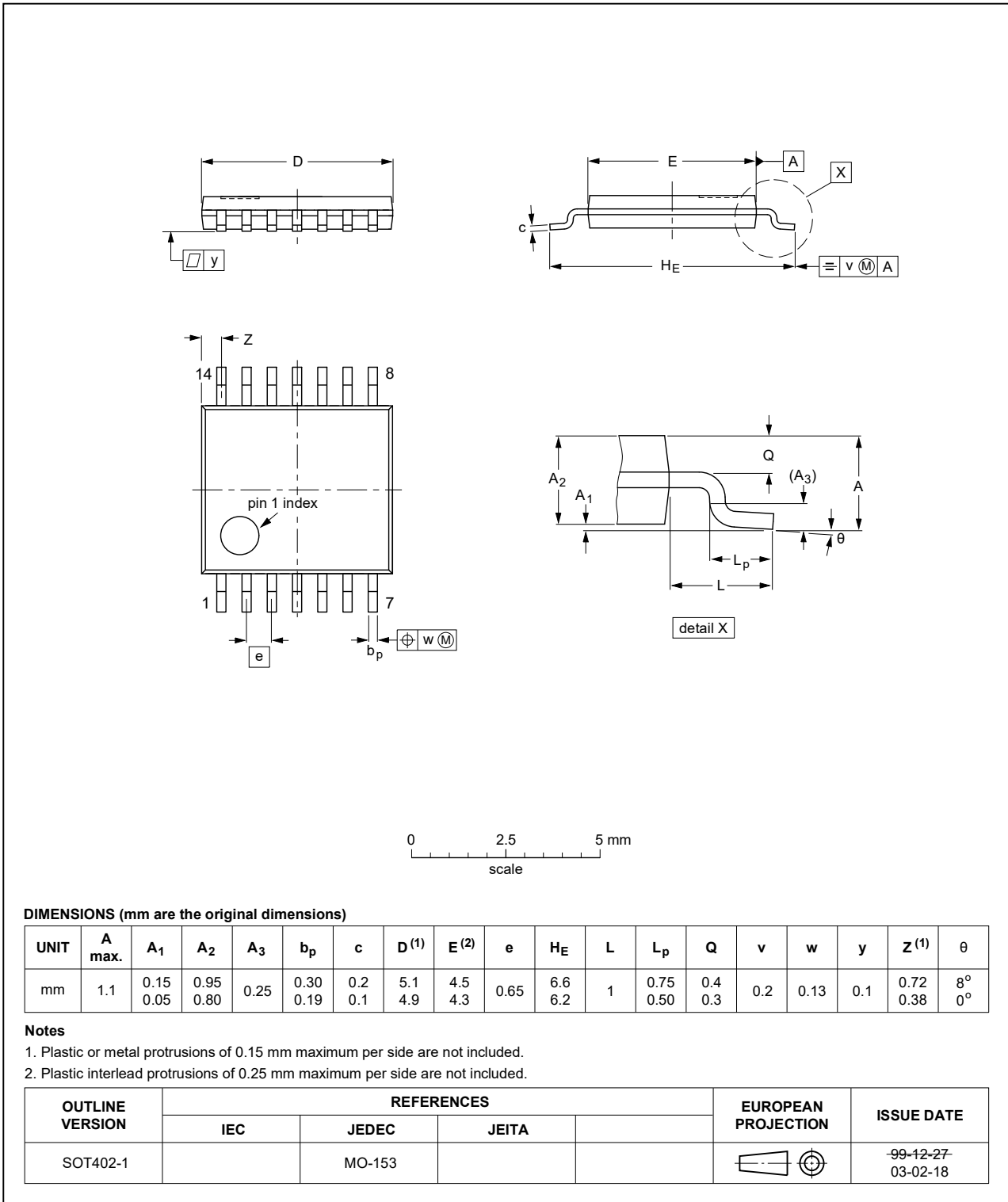


Fig. 10. Package outline SOT402-1 (TSSOP14)
