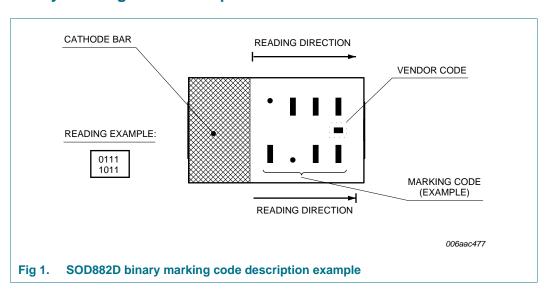






Fig 2. Diode capacitance as a function of reverse voltage; typical values






Fig 6. Package outline SOD882D (DFN1006D-2)
