

GETTING STARTED

Unpack the Kit

The i.MX 8M Nano UL DDR3L EVK (8MNANOD3L-EVK) is shipped with the items listed in Table 1. Ensure the items are available in the EVK box.

SETTING UP THE SYSTEM

The following will describe how to run the pre-loaded Linux image on the i.MX 8M Nano UL DDR3L EVK.

1 Confirm Boot Switches

The boot switches should be set to boot from the eMMC. Only SW1101[1-4] are used for boot. See table below.

BOOT DEVICE	SW1101	SW1102
eMMC/uSDHC3	0100XXXXXX	XXXXXXXXXXX

1 = ON 0 = OFF X = Don't Care

2 Connect USB Debug Cable

Connect the micro-B end of a USB cable into debug port J901. Connect the other end of the cable to a PC acting as a host terminal. Two UART connections will appear on the PC, one for the Cortex-M7 core, one for the Cortex-A53 core. The console print will output on "Enhanced COM port," which can be found in "Device Manager" of the PC. Downloaded from Arrow.com. If the serial port is not recognized, download and install updated drivers as listed in the "Debug Serial Console" section below.

Open the terminal window (i.e., Hyper Terminal or Tera Term), choose the COM port number that corresponds to the "Enhanced COM port" or the highest numbered port and apply the following configuration.

- Baud rate: 115200
- Data bits: 8
 - Parity: None
 - Flow control: None

3 Connect Power Supply

Connect the USB Type-C plug of the Power Supply to J302 (USB Type-C Port2), then power up the board using switch SW101.

Use only J302 for power delivery to the board.

4 Board Boot Up

During the boot process, there will be operating system status information scrolling on the terminal window of the PC. To work from the terminal window on the host PC, press enter at the terminal window to get the command prompt. Log in as root. Congratulations, you are up and running.

ADDITIONAL INFORMATION

Boot Switches

SW1101[1-4] are the boot configuration switches and the default boot device is eMMC/ uSDHC3, as shown in Table 4. If you want to try other boot devices, you need to change the boot switches to corresponding values as listed in Table 4.

Note: 1 = ON 0 = OFF X = Don't Care


