

# **IR Receiver Modules for Remote Control Systems**

#### **DESCRIPTION**

The TSOP11... series devices are the latest generation miniaturized IR receiver modules for infrared remote control systems. This series provides improvements in sensitivity to remote control signals in dark ambient as well as in sensitivity in the presence of optical disturbances e.g. from CFLs. The robustness against spurious pulses originating from Wi-Fi signals has been enhanced. The devices contain a PIN diode and a preamplifier assembled on a lead frame. The epoxy package contains an IR filter. The demodulated output signal can be directly connected to a microprocessor for decoding.

The TSOP111.., TSOP113.., and TSOP115.. series devices are designed to receive short burst codes (6 or more carrier cycles per burst). The third digit designates the AGC level (AGC1, AGC3, or AGC5) and the last two digits designate the band-pass frequency (see table below). The higher the AGC, the better noise is suppressed, but the lower the code compatibility. AGC1 provides basic noise suppression, AGC3 provides enhanced noise suppression and AGC5 provides maximized noise suppression. Generally, we advise to select the highest AGC that satisfactorily receives the desired remote code.

These components have not been qualified to automotive specifications.









Fig. 1 - Output Delay and Pulse-Width

Fig. 4 - Pulse-Width vs. Irradiance in Dark Ambient




Fig. 2 - Pulse-Width vs. Irradiance in Dark Ambient





Fig. 5 - Frequency Dependence of Responsivity






Fig. 6 - Sensitivity in Bright Ambient





Fig. 7 - Sensitivity vs. Supply Voltage Disturbances




Fig. 8 - Max. Envelope Duty Cycle vs. Burst Length





Fig. 10 - Relative Spectral Sensitivity vs. Wavelength






Fig. 11 - Horizontal and Vertical Directivity




Fig. 12 - Sensitivity vs. Supply Voltage



### **SUITABLE DATA FORMAT**

This series is designed to suppress spurious output pulses due to noise or disturbance signals. The devices can distinguish data signals from noise due to differences in frequency, burst length, and envelope duty cycle. The data signal should be close to the device's band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below.

When a data signal is applied to the product in the presence of a disturbance, the sensitivity of the receiver is automatically reduced by the AGC to insure that no spurious pulses are present at the receiver's output. Some examples which are suppressed are:

- DC light (e.g. from tungsten bulbs sunlight)
- · Continuous signals at any frequency




Fig. 13 - IR Emission from Fluorescent Lamp with Low Modulation




Fig. 14 - IR Emission from Fluorescent Lamp with High Modulation

- Strongly or weakly modulated patterns from fluorescent lamps with electronic ballasts (see Fig. 13 or Fig. 14)
- 2.4 GHz and 5 GHz Wi-Fi


