VLMU35CB2.-275-12. are ceramic based standard power UVC LEDs with quartz window for long life time. The package size is 3.45 mm x 3.45 mm x 1.78 mm and the radiant power typically 13.5 mW at 120 mA in a wavelength range of 270 nm to 280 nm.






Fig. 1 - Maximum Forward Current vs. Solder Point Temperature




Fig. 2 - Relative Radiant Power vs. Forward Current




Fig. 3 - Forward Current vs. Forward Voltage

Fig. 4 - Relative Radiant Power vs. Wavelength




Fig. 5 - Relative Radiant Intensity vs. Angular Displacement




Fig. 6 - Relative Radiant Power vs. Junction Temperature





Fig. 7 - Change of Forward Voltage vs. Junction Temperature




## TAPE AND REEL DIMENSIONS in millimeters






Technical drawings according to DIN specification





Fig. 8 - Vishay Lead (Pb)-free Reflow Soldering Profile (according to J-STD-020C)



### DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



## FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

## **RECOMMENDED METHOD OF STORAGE**

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity  $\leq$  60 % RH max.

After more than 168 h under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40  $^\circ\text{C}$  + 5  $^\circ\text{C}$  / - 0  $^\circ\text{C}$  and < 5 % RH (dry air / nitrogen) or

24 h at 60  $^{\circ}\text{C}$  + 5  $^{\circ}\text{C}$  and < 5 % RH for all device containers or

24 h at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC<sup>®</sup> standard JESD22-A112 level 3 label is included on all dry bags.
