




Fig. 1 - Forward Current vs. Ambient Temperature




Fig. 2 - Relative Radiant Sensitivity vs. Angular Displacement




Fig. 3 - Forward Current vs. Forward Voltage





Fig. 4 - Rel. Luminous Flux vs. Ambient Temperature




Fig. 6 - Relative Intensity vs. Wavelength




