





Fig. 1 - Forward Current vs. Ambient Temperature




Fig. 2 - Change of Forward Voltage vs. Ambient Temperature




Fig. 3 - Relative Luminous Intensity vs. Angular Displacement




Fig. 4 - Relative Luminous Intensity vs. Wavelength




Fig. 5 - Relative Luminous Intensity vs. Wavelength




Fig. 6 - Forward Current vs. Forward Voltage

Fig. 7 - Relative Luminous Intensity vs. Forward Current




Fig. 8 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 9 - Change of Dominant Wavelength vs. Ambient Temperature




Fig. 10 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 11 - Change of Dominant Wavelength vs. Ambient Temperature








METHOD OF TAPING / POLARITY AND TAPE AND REEL

SMD LED (VLM.3-SERIES)

Vishay's LEDs in SMD packages are available in an antistatic 8 mm blister tape (in accordance with DIN IEC 40 (CO) 564) for automatic component insertion. The blister tape is a plastic strip with impressed component cavities, covered by a top tape.




Fig. 12 - Tape Dimensions in mm for PLCC-2

REEL PACKAGE DIMENSION IN MILLIMETERS FOR SMD LEDS, TAPE OPTION GS08 (= 1500 PCS.)




Fig. 13 - Reel Dimensions - GS08





Fig. 14 - Reel Dimensions - GS18

SOLDERING PROFILE






Fig. 15 - Vishay Lead (Pb)-free Reflow Soldering Profile (acc. to J-STD-020)




Fig. 16 - Double Wave Soldering of Opto Devices (all Packages)





DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminium bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity ≤ 60 % RH max.

After more than 672 h under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40 $^{\circ}\text{C}$ + 5 $^{\circ}\text{C}$ / - 0 $^{\circ}\text{C}$ and < 5 % RH (dry air / nitrogen) or

96 h at 60 °C + 5 °C and < 5 % RH for all device containers or

24 h at 100 $^\circ\text{C}$ + 5 $^\circ\text{C}$ not suitable for reel or tubes.

An EIA JEDEC standard JESD22-A112 level 2a label is included on all dry bags.

ESD PRECAUTION

Proper storage and handling procedures should be followed to prevent ESD damage to the devices especially when they are removed from the antistatic shielding bag. Electrostatic sensitive devices warning labels are on the packaging.
