


Fig. 1 - Power Dissipation Limit vs. Ambient Temperature




Fig. 2 - Forward Current Limit vs. Ambient Temperature




Fig. 3 - Pulse Forward Current vs. Pulse Duration




Fig. 4 - Forward Current vs. Forward Voltage




Fig. 5 - Radiant Intensity vs. Forward Current




Fig. 6 - Relative Radiant Power vs. Wavelength




Fig. 7 - Relative Radiant Intensity vs. Angular Displacement






Fig. 8 - Lead (Pb)-free Reflow Solder Profile acc. J-STD-020 for Preconditioning acc. to $\mathsf{JEDEC}^{\textcircled{m}}$, Level 3




Fig. 9 - Blister Tape






Fig. 10 - Tape Dimensions in mm for PLCC-2
