






Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Thermal Impedance Z<sub>thJC</sub> Characteristics




Fig. 5 - Typical Reverse Recovery Time vs. dl<sub>F</sub>/dt




Fig. 6 - Typical Recovery Current vs. dl<sub>F</sub>/dt




Fig. 7 - Typical Stored Charge vs. dI<sub>F</sub>/dt




Fig. 8 - Typical  $dI_{(rec)M}/dt vs. dI_F/dt$




Fig. 9 - Reverse Recovery Parameter Test Circuit




Fig. 10 - Reverse Recovery Waveform and Definitions


