




Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Thermal Impedance  $Z_{\text{thJC}}$  Characteristics




Fig. 5 - Maximum Allowable Case Temperature vs. Average Forward Curren




Fig. 6 - Forward Power Loss Characteristics




Fig. 7 - Typical Reverse Recovery Time vs. dI<sub>F</sub>/dt





Fig. 8 - Typical Stored Charge vs. dl<sub>F</sub>/dt




### **DIMENSIONS** in inches (millimeters)
