

The VS-30BQ100GPbF surface mount Schottky rectifier has been designed for applications requiring low forward drop and small foot prints on PC boards. Typical applications are in disk drives, switching power supplies, converters, freewheeling diodes, battery charging, and reverse battery protection.




Fig. 1 - Maximum Forward Voltage Drop Characteristics (Per Leg)




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage (Per Leg)




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage (Per Leg)




Fig. 4 - Maximum Thermal Impedance Z_{thJC} Characteristics (Per Leg)




Fig. 5 - Maximum Average Forward Current vs. Allowable Lead Temperature




Fig. 6 - Maximum Average Forward Dissipation vs. Average Forward Current




Fig. 7 - Maximum Peak Surge Forward Current vs. Pulse Duration


