

DESIGN

The capacitors consist of a ceramic disc both sides of which are silver-plated. Connection leads are made of tinned copper having a diameter of 0.6 mm or 0.8 mm.

The capacitors may be supplied with kinked or straight leads with a lead spacing of 5 mm (0.20"), 7.5 mm (0.30") or 10 mm (0.40") and a lead length from 4 mm to 30 mm. The standard tolerance on capacitance is \pm 10 %. Encapsulation is made of gold colored epoxy-resin, flammable resistant in accordance with "UL 94 V-0".






