


Fig. 8 On-Resistance Variation with Temperature






Fig. 10 Gate Threshold Variation vs. Ambient Temperature








 $\rm V_{SD},$  SOURCE-DRAIN VOLTAGE (V) Fig. 11 Diode Forward Voltage vs. Current













