





1 Safe operating area




2 Max. transient thermal impedance




3 Typ. output characteristics

 $I_D = f(V_{DS}); T_j = 25 \text{ °C}$ parameter: V_{GS}




5 Typ. drain-source on-state resistance

 $R_{DS(on)} = f(I_D); T_j = 150 \text{ °C}$ parameter: V_{GS}




4 Typ. output characteristics

 $R_{DS(on)} = f(T_j)$ $I_D = 8A$




7 Typ. transfer characteristics

 $I_D = f(V_{GS}); |VDS| > 2 |I_D| R_{DS(on)max}$ parameter: T_i




8 Typ. gate threshold voltage

 $I_D = f(T_j)$ $I_D = 1 \text{mA}$




9 Typ. forward characteristics of reverse diode

 $I_F = f(V_{SD})$ parameter: T_i




10 Typ. drain-source breakdown voltage


