





Fig 1. Max. Forward Voltage Drop Characteristics (Per Leg)



**Fig 2.** Typical Values of Reverse Current Vs. Reverse Voltage (Per Leg)




Fig 3. Typical Junction Capacitance Vs. Reverse Voltage (Per Leg)







Fig 4. Max. Thermal Impedance ZthJC Characteristics (Per Leg)
