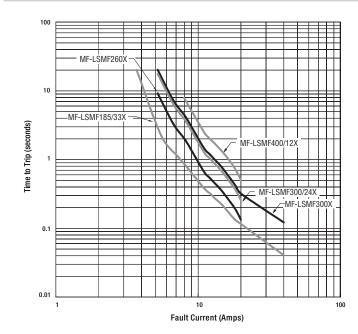

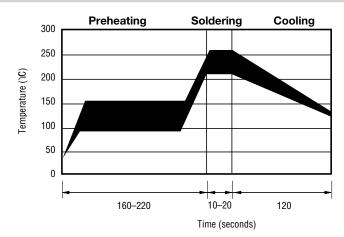

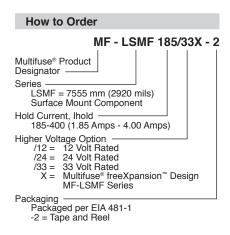

Typical Part Marking

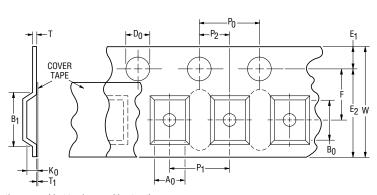

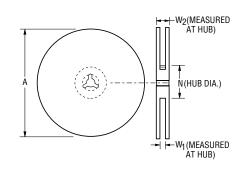

Application Notice
