

The Bridge Rectifier Diodes offer a forward current of 4 A with a choice of repetitive peak reverse voltages between 600 V and 1000 V.





Forward Current Derating Curve




Maximum Non-Repetitive Peak Forward Surge Current




Number of Cycles at 60 Hz


Forward Characteristics

Typical Junction Capacitance






Product Dimensions
