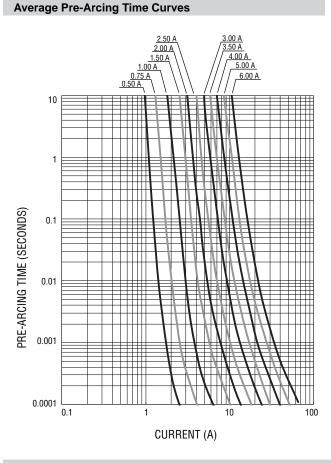

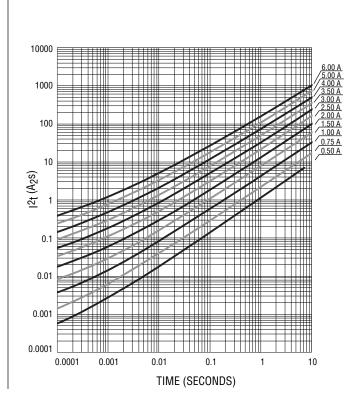

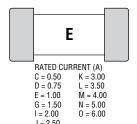

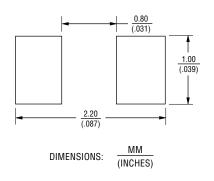

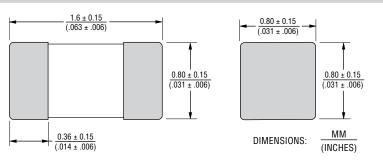

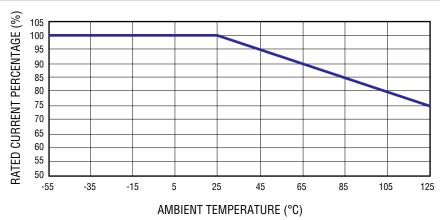
Recommended Pad Layout

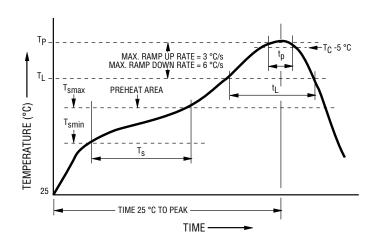


Current Rating Thermal Derating Curve

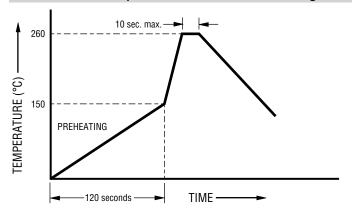
