General Information

The Bourns® Model CD0201-T2.0LC is an ultra-low capacitance bidirectional device tailored to protect ultra-high speed data lines. This model features high ESD protection: ±15 kV (air) and ±12 kV (contact) per IEC 61000-4-2, as well as superior surge clamping capability: 4 V @ 7 A (8/20 μs per IEC 61000-4-5).

The Model CD0201-T2.0LC is housed in a compact 0201 package (0.6 mm x 0.3 mm x 0.3 mm), minimizing PCB layout space and easing impedance matching.

This device is designed to protect one data line where the signal polarities are both positive and negative with respect to ground. Model CD0201-T2.0LC is not recommended to be used on lines connected to the DC supply.

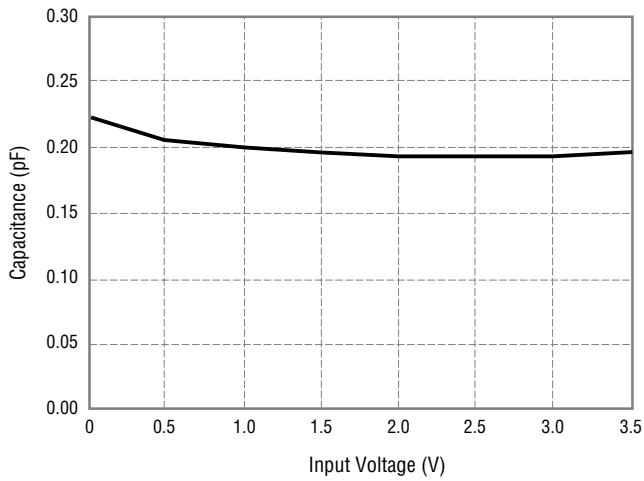

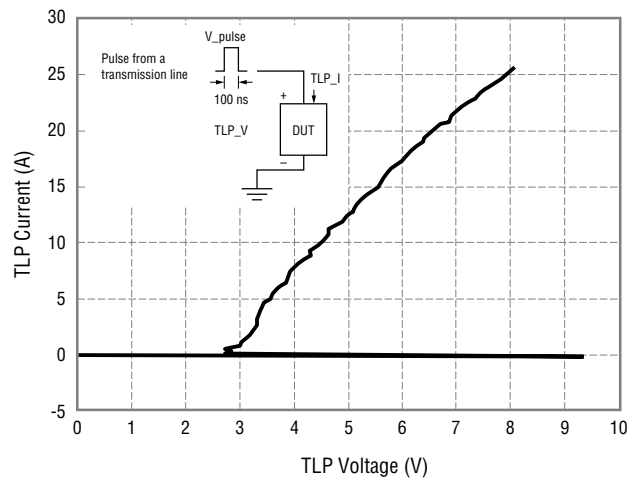

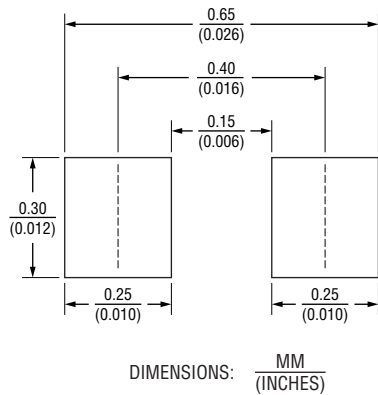

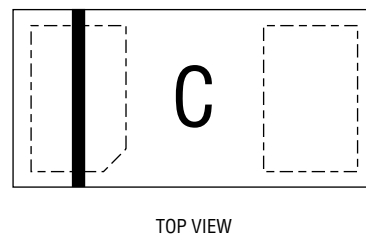
Product Dimensions

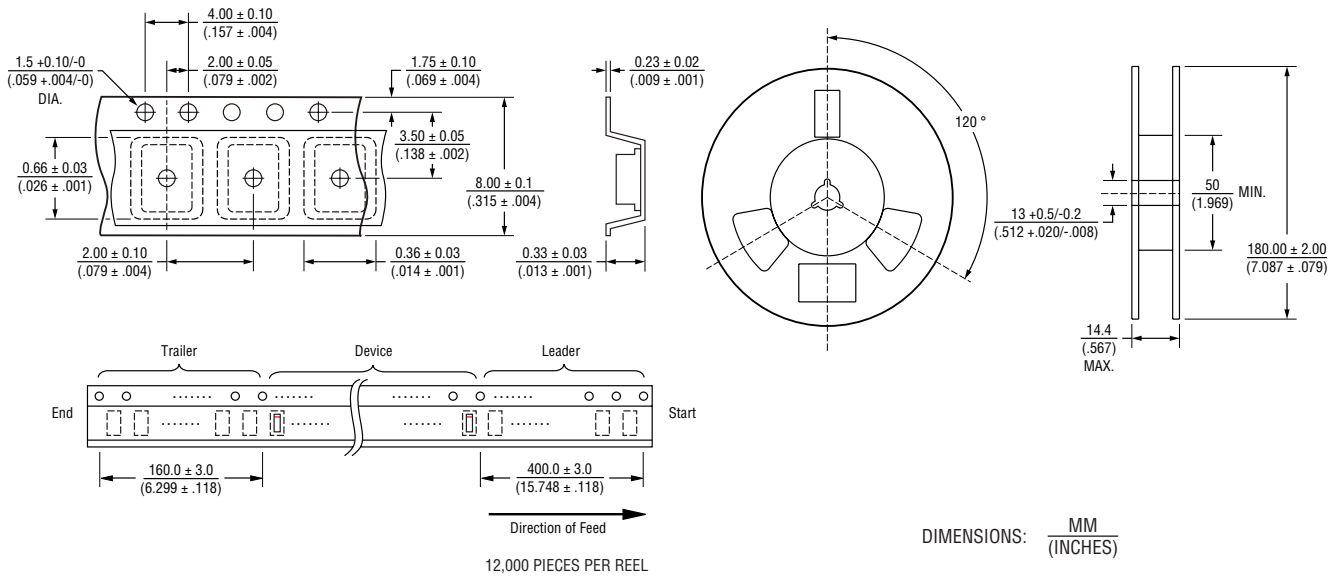
