

The Schottky Barrier Rectifier Diodes offer a forward current of 1 A with a choice of repetitive peak reverse voltage of 20 V up to 40 V.

Bourns® Chip Diodes conform to JEDEC standards, are easy to handle with standard pick and place equipment and their flat configuration minimizes roll away.








## **Reverse Characteristics**




## **Derating Curve**




#### **Derating Curve**




# **Reverse Characteristics**

**Derating Curve** 


