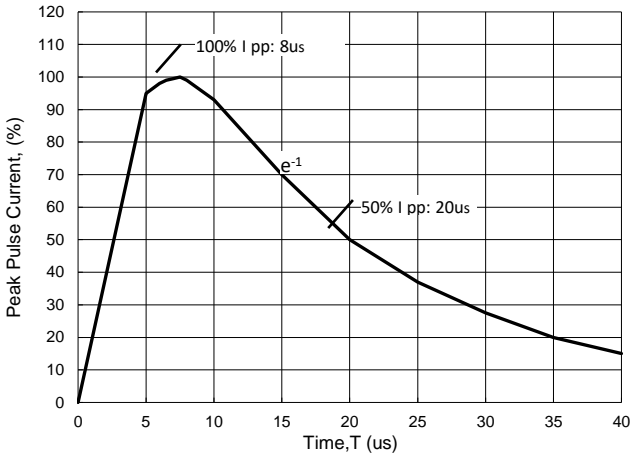

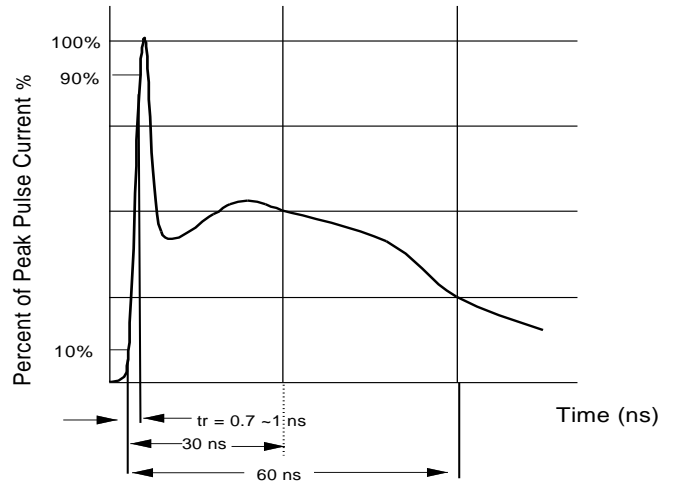

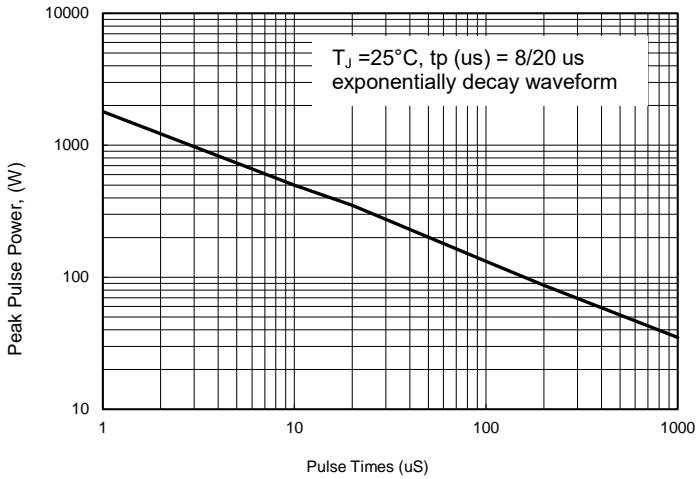
**FIG.1- 8/20us pulse waveform according to IEC 61000-4-5**



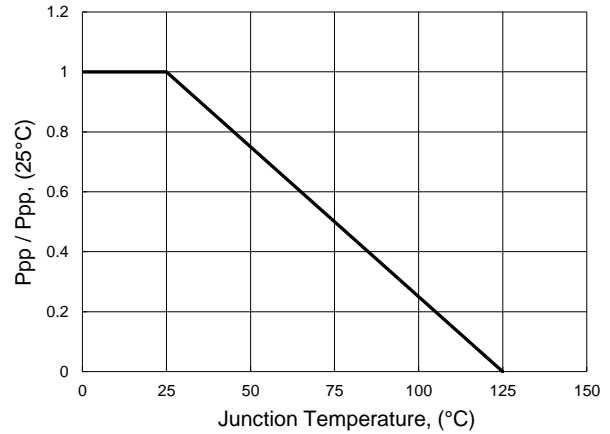
**FIG.2- ESD pulse waveform according to IEC 61000-4-2**



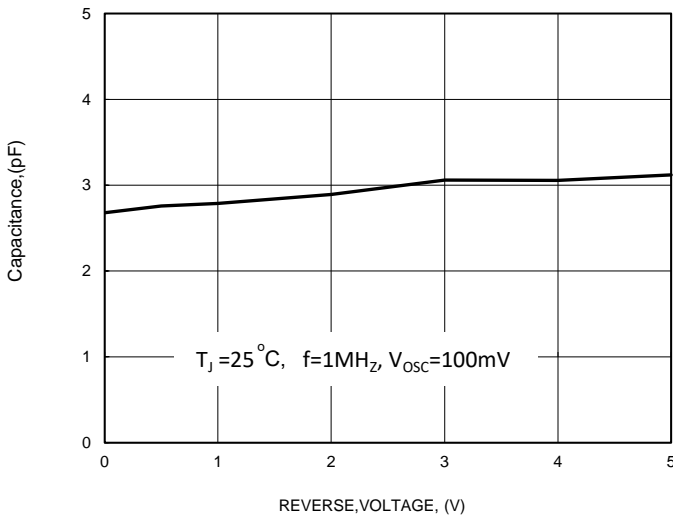
**Figure 3. Power Dissipation versus Pulse Time**



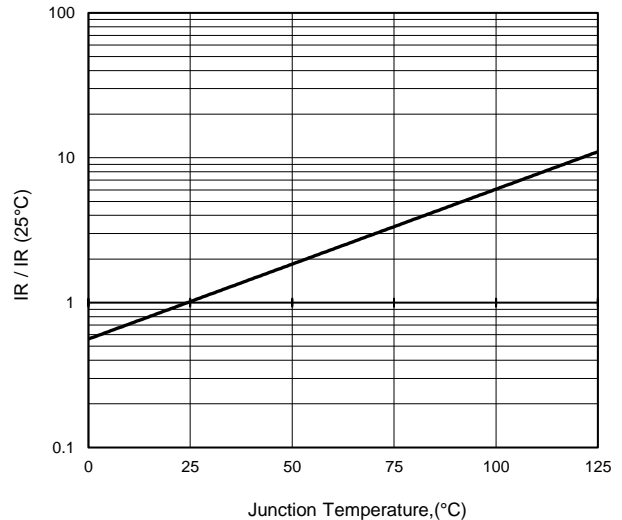
**FIG.4- peak pulse power versus Tj**

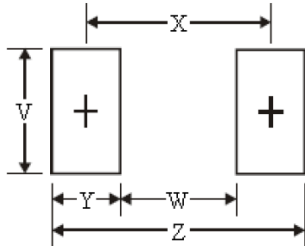
