

1. Zener Voltage (V_Z) Measurement Nominal zener voltage is measured with the device junction in the thermal equilibrium at the lead temperature (T_L) at 30°C ± 1°C and 3/8" lead length.
2. Zener Impedance (Z_Z) Derivation Z_{ZT} and Z_{ZK} are measured by dividing the ac voltage drop across the device by the ac current applied. The specified limits are for I_{Z(ac)} = 0.1 I_{Z(dc)} with the ac frequency = 60Hz.
3. Maximum Zener Current Ratings (I_{ZM}) The maximum current handling capability on a worst case basis is limited by the actual zener voltage at the operation point and the power derating curve.
