


Fig. 1 - Maximum Forward Voltage Drop vs. Instantaneous Forward Current




Fig. 2 - Typical Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Thermal Impedance Z_{thJC} Characteristics




Fig. 5 - Typical Reverse Recovery Time vs. di_F/dt





Fig. 6 - Typical Recovery Current vs. di_F/dt





Fig. 7 - Typical Stored Charge vs. di_F/dt




