



Block Diagram




Figure 1. Block Diagram




Figure 2. Minimum Load Current




Figure 3. Peak Output Current vs. Input-Output Differential Voltage




Figure 4. Adjustment Pin Current vs. Temperature




Figure 5. Ripple Rejection vs. Frequency




Figure 6. Load Regulation vs. Temperature




Figure 7. Line Regulation vs. Temperature




Figure 8. Output Voltage vs. Temperature




Figure 9. Thermal Shutdown




Figure 10. 15V Electronic Shutdown Regulator⁽⁵⁾






Figure 11. Slow Turn-On Regulator


