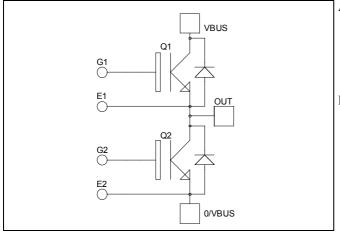
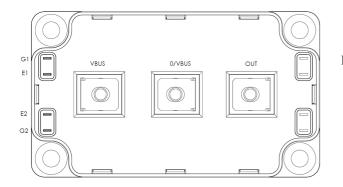



### SP6 Package outline (dimensions in mm)



#### **Typical Performance Curve**




rectangular Pulse Duration (Seconds)
